# 1. <u>RESOLUTION (04/13)</u>: to award contract for emergency debris removal at Main Pump Station.

WHEREAS, Superstorm Sandy damaged the Bayshore Regional Sewerage Authority Main Pump Station Wet Well, and

WHEREAS, as a result of inflow from excessive flooding throughout the neighboring communities the Main Pump Station Wet Well received large diameter solid debris, large quantities of grit and other materials that have accumulated in the wet well and threaten the operation of the main pumping system, and

WHEREAS, the Authority has an immediate need to remove this debris in its entirety and inspect the wet well for damage and repair, and

WHEREAS, the Staff Engineer and Consulting Engineer have developed a scope of work and received several quotations bids for the cleaning of debris from the Main Pump Station Wet Well, and

**WHEREAS**, on Friday, January 18<sup>th</sup>, 2013 the quotation bids were opened and read aloud and the apparent low bidder being Allied Construction Group of Parlin, N.J. in the amount of \$92,850.00.

**NOW THEREFORE BE IT RESOLVED** the Commissioners of the Bayshore Regional Sewerage Authority award the emergency contract for emergency clean-up in the Authority's Main Pump Station Wet Well to Allied Construction Group for a total price of \$92,850.00.

**BE IT FURTHER RESOLVED** that the Secretary shall cause a brief notice of the adoption of this Resolution to be published once in the Authority's designated official newspaper as required by law within ten (10) days of its adoption and will be posted on the BRSA official website.

### 7. <u>RESOLUTION (10/13):</u> to authorize State Contract purchase of UHF radio communication system

WHEREAS, the Authority phone system was in operable for a period of one week following Hurricane Sandy, and

WHEREAS, cell phone systems were severely limited during this same time period further limiting the Authority's ability to communicate during a period of critical emergency, and

WHEREAS, the Bayshore Regional Sewerage Authority is part of the State of New Jersey's Critical Infrastructure, and

WHEREAS, the Authority desires to mitigate the potential for future periods of communication failure during emergency situations, and

WHEREAS, the Authority may purchase a UHF radio communication system for all of its vehicles as well as essential on-site personnel which will be operated at all times including periods of power failure, cell tower failure or other disasters, and

WHEREAS, AR Communications at Eatontown, N.J. is an approved State Contract vendor for radio equipment and accessories under State Contract #A53764.

**NOW THEREFORE BE IT RESOLVED** the Commissioners of the Bayshore Regional Sewerage Authority award the contract for the purchase & programming of a Kenwood UHF 50 watt/512 channel mobile radio system to AR Communication of Eatontown, N.J. Contract #A53764 for \$10,728.13.

# 8. <u>RESOLUTION (11/13)</u>: to award contract for emergency video inspection of interceptor system

WHEREAS, Hurricane Sandy caused debris to enter the sewer system when flooding surcharged the surrounding community's sewer pipeline and destroyed hundreds of residential and commercial buildings, and

WHEREAS, the Authority is in need of an inspection of the flooded sections of the sewage interceptor system on an emergency basis, and

WHEREAS, the Authority staff engineer developed a request for proposal for the inspection of the affected authority sewer interceptor system as a daily price with an estimate of 20 days to complete, and

WHEREAS, on January 21, 2013 sealed bids were received and opened with the lowest bid being from National Water Main Cleaning Co., and

WHEREAS, the Authority Staff Engineer, Purchasing Agent and Executive Director have reviewed the bid and find it acceptable.

**NOW THEREFORE BE IT RESOLVED** the Commissioners of the Bayshore Regional Sewerage Authority award the contract for emergency video inspection of the sewerage interceptor system to National Water Main Cleaning Co at a price of \$85,700.00.

**BE IT FURTHER RESOLVED** a Notice of this award to be advertised in the official newspaper of the Authority, and the Executive Director is authorized to execute the contract for these services.

Pete Canal explained that bids were opened today, January 21, 2013, to hire a firm to video the collection system that was under water. He said that Gennett Fleming will oversee this project. Commissioner DiNardo asked what area is being done. Mr. Canal said that only the areas that were flooded by the hurricane would be checked.

Mr. Fischer stated that even the 36 inch pipes in the plant have debris in them. The pump stations and interceptors have debris. We are looking to inspect mainly Union Breach, Keansburg and Keyport.

Chairwoman Parsells stated that three sewer laterals on 3<sup>rd</sup> Street in Union Beach are uncapped. Mr. Fischer stated that BRSA has been providing letters to residents to speed the demolition and rebuild process for them. The letters inform the Construction Code Official that prior to demolition the laterals must be capped off. Mr. Fischer has sent a letter to the Union Beach Construction Code Official for Certification that laterals <u>are</u> being capped but so far has not received a response. We have to get the debris out of the lines because the next storm with just move down the lines and could potentially cause greater problems.

### 9. <u>RESOLUTION (12/13)</u>: to award a contract to Stoney Brook Regional Sewerage Authority for emergency disposal of thickened sludge.

WHEREAS, the Authority desires to enter into a contract for the emergency disposal of sewerage sludge until the repair of its sewage sludge incinerator is completed, and

WHEREAS, the Stoney Brook Regional Sewerage Authority has been accepting the Authority's thickened sludge since the destruction of the Authority's incineration system on October 29, 2012 and has provided uninterrupted disposal services since that date, and

WHEREAS, the uninterrupted disposal of sewage sludge is a critical component in the safe operation of the Bayshore Regional Sewerage Authority that will ensure the health, safety and welfare of the community and BRSA staff, and

WHEREAS, the Stoney Brook Regional Sewerage Authority can only guarantee the uninterrupted disposal of sewerage sludge if the Authority contracts with them and commit their sludge volume to its disposal site until the completion of repairs of the Authority sludge incinerator system.

**NOW THEREFORE BE IT RESOLVED** the Commissioners of the Bayshore Regional Sewerage Authority award a contract for sludge disposal on an emergency basis to Stoney Brook Regional Sewerage Authority at a price of \$50.00 per cubic yard.

**BE IT FURTHER RESOLVED** the Executive Director is authorized to place a Notice of this award in the official newspaper of the Authority and to execute the contract with Stoney Brook Regional Sewerage Authority.

# 10. <u>RESOLUTION (13/13)</u>: to authorize R3M Engineering to prepare conceptual architecture design for repair of the Administration Building.

WHEREAS, the Bayshore Regional Sewerage Administration Building was damaged during the flooding of Hurricane Sandy, and

WHEREAS, the Authority desires to repair the Administration Building for the health, safety and welfare of the administrative staff, community and visitors, and

WHEREAS, R3M Engineering has provided a scope of work to prepare a conceptual architectures design through their sub-consultant Dunzik Besold Architects for a price not to exceed \$7000.00, and

WHEREAS, the Authority desires to move forward with this work.

**NOW THEREFORE BE IT RESOLVED** the Commissioners of the Authority authorize R3M Engineering to prepare conceptual architecture design of the Administration Building at a cost not to exceed \$7000.00.

### 11. <u>RESOLUTION (14/13):</u> to authorize Chavond Barry Engineering to design the repair of the Dorr Oliver Incinerator

WHEREAS, the Bayshore Regional Sewerage Authority owns and operates a Dorr Oliver Incinerator for the processing of sludge in accordance with NJPDES Permit No.: PCP11001; ("the Permit"); and

WHEREAS, the Executive Director and BRSA Engineer have presented the Board with a proposal from the firm of Chavond Barry Engineering, dated January 21, 2013 to perform Engineering Services for the repairs to the Dorr-Oliver Incinerator as a result of Hurricane Sandy for a total cost not to exceed \$145,194.00; and

WHEREAS, the Commissioners of the Bayshore Regional Sewerage Authority deemed it in the best interest of the Authority and the customers towns that it serves, to utilize the services of Chavond Barry Engineering to design the repair work to be performed; and

WHEREAS, this action is being taken without competitive bidding as a professional service contract which is an allowable exception in accordance with 40A:11-5 et seq. of the Local Public Contracts Law; and

WHEREAS, the Bayshore Regional Sewerage Authority has funding available to procure these services.

**NOW THEREFORE BE IT RESOLVED** the Board hereby awards this contract to Chavond Barry Engineering at a cost not to exceed \$145,194.00 and authorizes the Executive Director to execute all necessary documents required,

**BE IT FURTHER RESOLVED**, the Local Public Contract Law (NJSA 40A:11-1 et seq.) requires a Resolution authorizing the approval with competitive bidding must be publicly advertised;

BE IT FURTHER RESOLVED that the Secretary shall cause a brief notice of the adoption of this Resolution to be published once in the Authority's designated official newspaper as required by law within ten (10) days of its adoption and will be posted on the BRSA official website.

Discussion by Incinerator Engineer

Chris Doelling of Chavond Barry Engineering inspected the Incinerator Building. He stated that the Dorr Oliver Incinerator was not HOT when the salt water hit it. He said that salt water did damage to the refectory, damaged the electrical system, pumps, pipes, etc. He said that with a quick fix the Dorr Oliver could be restarted within 6 months after the receipt of bids. He said instead of replacing the brick inside the incinerator, they can use a lining spray substance call Gunite. It's quicker, faster and could last about 2 to 3 years which is when the NIRO would be fully on-line with needed upgrades. The Dorr Oliver incinerator needs specs written ASAP, the air blower refurbished, new wiring, re-route conduit and we will use whatever parts we can to get it back on line.

Mr. Doelling explained that with the NIRO some of the equipment has to be brought up from the basement, it has to have a special dome built, has special brick which takes 14 to 16 weeks to order and the regulations are going to be revised in 2016. It makes more sense to rebuild the NIRO to the new State Standards.

Mr. Fischer stated that in 6 months we could fix the Dorr Oliver, get the specs written for the NIRO and stop the sludge hauling through Union Beach. We have gotten some odor complaints in the last couple of weeks due to the trailer mounted press which is outdoors but we now have our belt press running which is located indoors. We will soon return the portable belt press. Commissioner Sutton asked if the State would let us run the Dorr Oliver.

Commissioner Vella said that we should get the States OK before we spend any money.

Mr. Fisher said that if the DEP says NO, we would have to go down and plead our case, and their decision will come before we spend money to rebuild.

Commissioner Khachaturian asked how much does it cost to haul the sludge.

Mr. Fischer said it was about \$1,2 million dollars for the year.

Commissioner DiNardo asked how long can we run the Dorr Oliver Incinerator.

Mr. Fischer said the Dorr Oliver was 1536 hours and the NIRO is 24/7.

The Commissioners said to improve the quality of life in Union Beach, with summer not far off, and to stop the truck hauling, we should proceed to repair the Dorr Oliver.

### 12. <u>RESOLUTION (15/13)</u>: to amend Chavond Barry contract for General Consulting Services

WHEREAS, the Bayshore Regional Sewerage Authority owns and operates two (2) fluidized bed Incinerators at the treatment plant facilities; and

WHEREAS, the Bayshore Regional Sewerage Authority (BRSA) previously authorized the firm Chavond-Barry Engineering (CBE) to perform General Consulting Services for the Incinerators for an annual cost not to exceed \$15,640.00 by Resolution No. 31/12; and

WHEREAS, as a result of flooding damage CBE has performed additional Engineering services beyond their original scope, and

WHEREAS, CBE is requesting a budget amendment in the amount of \$15,000.00 for additional engineering services necessary for Incineration repairs due to Hurricane Sandy; and
