MINUTES FOR REGULAR MEETING MONDAY, NOVEMBER 16, 2015

At 7:03 P.M. on Monday, November 16, 2015 Chairman Sutton called the meeting of the Bayshore Regional Sewerage Authority to order and makes the following announcement:

I hereby announce that pursuant to Section 5 of the Open Public Meetings Act, that adequate notice of this meeting has been sent to the Asbury Park Press and is on the BRSA Official Website. Notice has also been sent to the Clerks of Aberdeen, Hazlet, Holmdel, Keansburg, Keyport, Matawan, Union Beach and Marlboro and the Western Monmouth Utilities Authority. This notice is also posted in the lobby of the Bayshore Regional Sewerage Authority Administration Building.

Chairman Sutton asked all in attendance to stand for the Pledge of Allegiance and a Moment of Silence for the safety of US Troops all over the world and the victim's in Paris.

Chairman Sutton requested a roll call of attendance:

Mr. Fischer advised the Board that in 2012 a No Further Action Letter from NJDEP was received regarding the below ground piping leak from the above ground fuel storage tank at the Maintenance Garage. Sampling conducted at that time detected slightly above clean-up criteria of 1.0 1.1 DCE

<u>PRESENTATION</u> – O'Brien & Gere presented their proposal for additional Licensed Site Remediation Professional services at the BRSA. This proposal is to complete a preliminary assessment and site investigation of 1,1 DCE in the ground water near the maintenance garage at a cost of \$59,600.

Reports

Executive Directors Report, BRSA Projects, Special Reports & Connection Applications Mr. Fischer reported:

- Disaster Recovery Expense is currently at \$17,767,178.07.
- Stone Hill Construction Payment #6 (NIRO)and Remsco Payment #2 (Pump Station)
- Stone Hill is approx.70% done with the Flood Wall on the Niro and Dorr Oliver Incinerators. They are also working on the Refractory and Dome in the NIRO and Carbon Scrubber Pad Foundation
- Remsco is installing the Flood Wall and working on the elevation of the Motor Control Center in the Main Pump Station
- Shorelands Construction (Various Buildings) is mainly working on the Flood Walls on the Administration and Lab Buildings.
- On November 20th the NJ Sewerage & Municipal Utility Authority Electrical Supply Aggregation will be opening bids for Basic Generation Services for plant electric for 12, 18, or 24 months commencing May 2016. The Authority is part of this group and Mr. Fischer recommends going out to bid early with this group.
- Stone Hill Contracting submitted payment #6 in the amount of \$609,724.64 and Remsco Contracting submitted payment #2 in the amount of \$78,453.90.

Staff Engineer Report Pete Canal Reported:

- West Keansburg Force Main Rehabilitation Project, C.85 contract awarded to Cruz Construction. Pre-con meeting is being held on November 23rd.
- Proposal from Gannett Fleming for Phase II. Proposal is being reviewed for possible Award at the December Meeting
- Resolution to award Fuel Oil Contract to Allied Oil, LLC as the low bidder.
- RFP for Annual Roofing Inspection & Repair a Purchase Order will be issued to Conti Roofing for \$1,500 for the yearly inspection
- Turbo Blower Procurement, Ct.88 Resolution for a 350 Hp blower awarded to APG-Neuros in the amount of \$308,500. Pete reported there will be a Change Order next month for costly add-ons that we don't need which should bring the cost down to about \$270,000

Chairman Sutton asked Pete if the Project was ready to be put on line. Pete said that they are having the 30% Design meeting this Thursday. This new blower is going into Building #1 and will be moved to Building #2 when the buildings are combined.

Commissioner Steiner asked if the Pump Station on Texas Road heading towards Route 9 was Western Monmouth's. Mike answered yes and stated that they discharge to the BRSA. Chairman Sutton said they are doing a complete rehab of the entire building.

Consulting Engineer – R3M Manuel Ponte Reported:

• 4th Ouarter 2014/2015 Final Flow Report was handed out. Letters from CME

(Hazlet) and T&M (Union Beach) certification of their EDU's is included in the report. Manuel reported that the Various Authority Building Contract is well underway and proceeding very well.

Superintendent's Report Mike Broyles Reported:

- Last months flow was again very low at 200.105 mg
- Planned Shut Down of the Dorr Oliver didn't occur since it has been running better then when last reported, however over the weekend had minor complication that has been fixed and it continues to burn sludge.
- Received Odor Complaints all from 9th Street all windy days in that direction.
- Lab did make up sample for Suspended Solids and didn't get an acceptable result. Currently investigating to seeing if we can make a determination why we can't meet acceptable results which we did throughout the year.

Chairman Sutton asked about the odor complaints and if we have heard from the County Health Department. Mike said he has not heard anything and no one from the health department has contacted him lately. The County may also be sending someone to investigate a noise complaint but have not contacted Mike recently.

WHEREAS, two bidders, Allied Oil and Petroleum Traders submitted bids that comply with the Bid Specifications and have been reviewed by the Authority's General Counsel, and

WHEREAS, after review of the bids, it appears Allied Oil, LLC of Parlin, N.J. has submitted the lowest responsible bid in compliance with the Bid Specifications with a bid price of \$258,691.00; and

WHEREAS, the Certified Purchasing Agent, the Staff Engineer and the General Counsel recommend the Contract be awarded to Allied Oil, LLC.

NOW THEREFORE BE IT RESOLVED that Allied Oil, LLC of Parlin New Jersey be and is hereby awarded the Contract for Furnishing and Delivery of #2 Fuel Oil for a one year period according to the terms and conditions of the bid and contract documents

RESOLUTION NO. (125/15): To Authorize Gabel Associates to Act as Authority Energy

Agent and to Execute a Certificate of Acceptance for the Lowest Bidder for Basic Generation Services Commencing May 2016

WHEREAS the Bayshore Regional Sewerage Authority (Authority) is a member of the New Jersey Sewerage and Municipal Utilities Authority Electric Supply Aggregation (Aggregation Group); and

WHEREAS, the Authority desires to continue its purchase of electrical basic generation services (BGS) for the treatment plant and pump stations as a member of the Aggregation Group to benefit from the lower cost of electricity; and

WHEREAS, the Authority desires to (1) enter into an agreement with Gabel Associates as Energy Agent for the Aggregation Group for purposes of Purchasing Aggregate Electrical Power and (2) Authorize the Executive Director to execute a Certificate of Acceptance for the winning bidder on the date bids are accepted by the Aggregation Group; and

WHEREAS, electronic bids will be received for the supply of BGS for a 12, 18 and 24 month term on November 20, 2015 at 11:30 a.m. at the Ewing Lawrence Sewerage Authority; and

WHEREAS, the successful bidder will commence supply of BGS to the Aggregation Group as of the first meter reading in May 2016;

NOW THEREFORE BE IT RESOLVED, the Commissioners of the Bayshore Regional Sewerage Authority authorize Gabel Associates to act as Energy Agent for the Authority as a member of the Aggregation Group for a fee of \$0.0005 per KWH which shall be included in the BGS bid price.

BE IT FURTHER RESOLVED the Commissioners authorize the Executive Director to sign a Certificate of Acceptance for the winning bidder contingent upon the recommendation of the Energy Agent.

RESOLUTION NO. (126/15): To Contract with O'Brien and Gere Engineers, Inc. to Conduct a Preliminary Assessment and Remedial Investigation of 1, 1 DCE at the Maintenance Garage

WHEREAS, in May of 2005 the Bayshore Regional Sewerage Authority ("Authority") detected a chlorinated hydrocarbon 1, 1 DCE, slightly above the NJDEP Groundwater Quality Standard (GWQS) adjacent to the Maintenance Shop; and

WHEREAS the Authority needs to retain a Licensed Site Remediation Professional (LSRP) conduct a Preliminary Assessment (PA) and Site Investigation (SI) to determine the concentration, extent, direction and possible sources of the chlorinated hydrocarbon; and

WHEREAS, the firm of O'Brien and Gere Engineers, Inc. is familiar with the Authority compliance history having performed required compliance inspections and successfully investigated and closed out a previously open cases; and

WHEREAS, O'Brien and Gere Engineers, Inc. met with Authority staff and developed a phased approach to the PA/SI for 1,1 DCE which will allow possible early completion of the SI as presented in their letter proposal dated September 3, 2015; and

WHEREAS, O'Brien and Gere Engineers, Inc. proposes to act as Authority's LSRP and to complete the PA/SI for the price not to exceed \$59,600; and

WHEREAS funds are available for this purpose; and

WHEREAS, the proposal has been evaluated by the Authority Engineer and Executive Director and found to be reasonable;

NOW THEREFORE BE IT RESOLVED, the Commissioners of the Bayshore Regional Sewerage Authority award the contract for a Preliminary Assessment and Site Investigation of the chlorinated hydrocarbon 1,1 DCE at the maintenance building to O'Brien and Gere Engineers Inc. for the not to exceed price of \$59,600 as a professional services contract in accordance with NJSA 40A:11-5.

WHEREAS, on Friday, November 13, 2015 at 10:00 AM the Authority received and opened sealed bids for Furnishing, Delivery, and Commissioning of a 350 Hp Turbo Blower; and

WHEREAS, one bid was received in the amount of \$308,500.00; and

WHEREAS, the bid was reviewed by the Consulting Engineers, Hazen and Sawyer and the Authority Attorney, John Napolitano and found to be acceptable; and

WHEREAS, the Bayshore Regional Sewerage Authority has funding available for this project, NOW THEREFORE BE IT RESOLVED, the Commissioners of the Bayshore Regional Sewerage Authority hereby award the contract for Furnishing, Delivery, and Commissioning of a 350 Hp Turbo Blower to APG-Neuros of Quebec, Canada for the price of \$308,500.00.
