MINUTES FOR **REGULAR MEETING MONDAY, OCTOBER 17, 2016**

Chairman Pisano called the Meeting Regular Meeting of the Bayshore Regional Sewerage Authority to order at 7:04 PM and makes the following announcement:

I hereby announce that pursuant to Section 5 of the Open Public Meetings Act, that adequate notice of this meeting has been sent to the Asbury Park Press and is on the BRSA Official Website. Notice has also been sent to the Clerks of Aberdeen, Hazlet, Holmdel, Keansburg, Keyport, Matawan, Union Beach and Marlboro and the Western Monmouth Utilities Authority. This notice is also posted in the lobby of the Bayshore Regional Sewerage Authority Administration Building.

Chairman Pisano asked all in attendance to stand for the Pledge of Allegiance and a Moment of Silence for the safety of US Troops all over the world.

REPORTS

Executive Directors Report, BRSA Projects, Special Reports & Connection Applications Mr. Fischer Reported:

- The NIRO is running very well and the Stack Test will be done on Tuesday, October 18th and Wednesday, October 19th.
- Hazen and Sawyer is here tonight to talk about the progress on Contract 74S and potential issues with the CPPE Mercury Scrubber at other locations.
- Remsco removed the old MCC from Return Sludge Pump Station #1. They are about 90% complete on their projects.
- Shorelands Various Authority Buildings is complete. They are working on a punch list and waiting on a couple of refurbished pumps.
- Phase II Combined Blower Building Contract 80S will commence shortly. The muscle wall will be

- Installed around Blower Building #1 which will serve as the temporary blower process for the entire plant while Blower Building #2 is converted to the Combined Blower Building.
- Contract 81S We received the Land Use Permit and are awaiting the OK from the DEP to authorize the advertisement for bids. Hope to award this Contract by the December meeting.

Disaster Funding

- Stone Hill Contracting submitted payment application #16 in the amount of \$276,153.22 which has been found acceptable by the Consulting Engineer Hazen and Sawyer.
- Remsco Contracting did not submit a payment application on time.
- Shorelands Construction submitted payment application #10 for \$30,337.81 which has been found acceptable by the Consulting Engineer R3M Engineering.
- The combined cumulative Phase 1 project payments excluding October total \$20,744,083.99. The FEMA reimbursable portion stands at 61%, or \$12,761,943.61.
- NJEIT Phase II Short-Term Loan Stone Hill Contracting Combined Blower Building Project 80S payment application #2 in the amount of \$92,975.54 for shop drawings, materials and mobilization costs.

Coastal Barrier Resource System

We spoke to US Fish and Wildlife Service and met with the Army Corp of Engineers regarding the CBRS boundary approaching the plants fence line. We suggested a 100 foot buffer along the fence for maintenance and additional footage by the Single Sampling Point which they approved. The new boundary shows the line hugging the turbine base and they found no technical reason for moving that boundary line. The toe of the wall will be approximately 50 feet of the turbine base.

2017 Budget

• The budget was sent to everyone for review. This budget is around \$68,000 or 0.7% decrease from last year.

Mr. Fischer explained the increases and/or decreases in each category. He advised the Board that once the Preliminary Budget is approved it is sent down to the DCA for their approval. At the December meeting, a Public Hearing is held and adoption of the budget.

Mr. Fischer said the Finance Committee met and approved the Preliminary Budget.

Staff Engineer Report Pete Canal Reported:

Pete introduced Ed Barboe and John Wojnas from Hazen and Sawyer.

Ed spoke on NIRO update – last Saturday, October 8th, the NIRO started heating up and sludge was introduced on Friday, October 14th. The incinerator is running very well. Temps are very steady. The last stage incineration process emissions control is the Mercury Absorber. It's a large fiberglass reinforced plastic vessel outside the NIRO building. In August of this year at 2 sites, one in North Carolina and one in Connecticut, the treatment plant Mercury Scrubbers had high temperature incidents without the incinerator in operation which caused damage to the Mercury units. Both Connecticut and North Carolina have the same Mercury Scrubber as the one installed at Bayshore. To date we have not received adequate information as to what is causing the problem. The Stack test is going to proceed without the Mercury Scrubber on line for the time being. This will give the Authority and the Contractors time to find out more about what happened at the other two facilities.

Mr. Fischer said he contacted the DEP to let them know about the Mercury Scrubber concerns. The DEP agreed we could run the Stack Test and the incinerator without the Mercury Absorber until March of 2017. Chairman Pisano asked what would happen if we don't solve this problem by March, 2017. Mr. Fischer was advised by DEP that we would have to submit a Permit Modification taking the Mercury Scrubber out of the permit provided we can pass the Stack Test without it. Communication between the Contractors, Engineers and Authority continues.

Other items presented by the Engineer, Pete Canal are:

- Approve closeout and acceptance of the Maintenance Bond for Contract 85-West Keansburg Force Main Rehabilitation-Cruz Construction
- Award Amendment No. 1 to R3M Engineering for engineering services for the Standby Generator Service, Repair and Appurtenant work- Contract #83-in the amount not to exceed \$14,000
- Approve the sanitary sewer connection & signing of the TWA consent form for Broad Street Plaza (aka The Edge at Matawan) in Matawan
- Approve the Developer Agreement reviewed by our conflict Attorney for Broad Street Plaza in Matawan.
- Approve a Bond reduction to a total revised Bond amount of \$642,874 to Regency @ Holmdel
- Approve Final Change Order No. 1 for Contract 89-Stone Hill Construction-Turbo Installation- in the credit amount of (\$23,265) and close-out the project.
- Approve a one year extension to Allied Fuel Oil at the same price and conditions for the time period December 15, 2016 to December 15, 2017.

Consulting Engineer – R3M Manuel Ponte Reported:

- Various Plant Building, Contract 71S, project is essentially complete. The close-out will come in with a credit amount from the Contractor Shorelands Construction.
- Stand-By Generator-Contract amendment request for Engineer Services. Manuel Ponte explained the additional time required to complete the Generator Project including the additional load testing required, failure of turbo charger for Generator #3. Costs outside R3M's scope of work came to a total of \$14,000 that will take us to the end of the Project.

Manuel gave a lengthy presentation on the Recommendations for the Improvements to Odor Control System #1. Engineer's estimate includes labor and equipment costs and Contractor's O&P = \$375,000. Mr. Fischer said that this work has been put in the 2016 Capital Budget and would like to ask R3M to give a proposal for the design of the odor control improvement.

Superintendent's Report Mike Broyles Reported:

- Treatment Plant flow for September is less than 180.893 mgd, the lowest since 1998
- Effluent quality not quite what it was last month due to taking Plant #1 off line but still within Permit limits.
- Dorr Oliver Incinerator ran good for the month, taken down for press work.
- The plant had odor complaints most consistent with wind speed.

- DEP was here the beginning of September for the last summer inspection tour. No issues were reported.
- Writing Renewal Permits for 4 out of 5 industrial dischargers, their permits expire the end of the year. The DEP instituted a new Emergency Discharge Limitation Plan because of Sandy.
- In the future, if flooding prevents the Authority from processing sewage the DEP wants all industries to cease discharge of industrial waste to the Sewer System.

WHEREAS, the Annual Budget and Capital Budget for the Bayshore Regional Sewerage Authority for the fiscal year beginning, January 1, 2017 and ending, December 31, 2017 has been presented before the governing body of the Bayshore Regional Sewerage Authority at its open public meeting of October 17, 2016; and

WHEREAS, the Annual Budget as introduced reflects Total Revenues of \$9,764,436 Total Appropriations, including any Accumulated Deficit if any, of \$7,334,436 and Total Unrestricted Net Position utilized of \$0; and

WHEREAS, the Capital Budget as introduced reflects Total Capital Appropriations of \$14,330,000 and Total Unrestricted Net Position planned to be utilized as funding thereof, of \$2,430,000 and

WHERAS, the schedule of rates, fees and other charges in effect will produce sufficient revenues, together with all other anticipated revenues to satisfy all obligations to the holders of bonds of the Authority, to meet operating expenses, capital outlays, debt service requirements, and to provide for such reserves, all as may be required by law, regulation or terms of contracts and agreements; and

WHEREAS, the Capital Budget/Program, pursuant to N.J.A.C. 5:31-2, does not confer any authorization to raise or expend funds; rather it is a document to be used as part of the said Authority's planning and management objectives. Specific authorization to expend funds for the purposes described in this section of the budget, must be granted elsewhere; by bond resolution, by a project financial agreement, by resolution appropriating funds from the Renewal and Replacement Reserve or other means provided by law.
