x <u>MINUTES FOR</u> <u>REGULAR MEETING</u> <u>MONDAY, JANUARY 30, 2017</u>

At 7:00 P.M. Chairman Pisano called the Meeting Regular Meeting of the Bayshore Regional Sewerage Authority to order and made the following announcement:

This notice is also posted in the lobby of the Bayshore Regional Sewerage Authority Administration Building.

REPORTS

Executive Directors Report, BRSA Projects, Special Reports & Connection Applications Mr. Fischer Reported:

Disaster Recovery

- Stone Hill Contractor's progress on the NIRO project included installing lights in the basement, equipment tests, control panel startup and ceiling work in the new control room.
- NIRO incinerator has been running in a stable and efficient manner.
- Hazen arranged a meeting with CPPE, SHC, IFCO & the Authority in January to request CPPE rootcause analysis of the incident in North Carolina and certain safeguards for the Authority Scrubber. Hazen also requested the presence of CPPE during and after start up.
- Remsco Contracting 73S- have been working on drop down gates and painting in the Return Sludge Pump Station #1, painting and HVAC ductwork the Main Pump Station and punch list work.

- Shorelands Construction is complete on Contract 71S
- Work on the Combined Blower Buildings Project 80S installing flood wall protection system, cleaning of Aeration basins 1 & 2.
- Power Distribution Project Contract 81S seven (7) bidders submitted bids on January 10, 2017 with the lowest bid submitted by PKF Mark III

Disaster Funding-Phase I

- Stone Hill Construction submitted payment application #19 in the amount of \$103,659.54, Remco Contracting submitted payment application #16 in the amount of \$106,327.06. Shorelands did not submit a payment application.
- The combined project payments excluding January totals \$22,857,282.07. Construction costs are 89% of that amount, engineering costs are 10%, administrative costs are .05% and NJEIT Technical fee is .05%. FEMA reimbursable stands at 62% or \$14,224,112.55.
- Contract 74S Hazen & Sawyers, Ed Barboe and John Wojnas were present at the meeting to discuss Change Order #6 on the Incinerator Project. They explained the Change Order line item detail and the process of requesting FEMA reimbursement for Change Order work.

• Stone Hill Contraction - Project 80S - Combined Blower Building- payment application #4 was submitted in the amount of \$489,869.93.

2017 Professional Appointments

• The BRSA Pay to Play Policy was discussed and Mr. Fischer will be soliciting proposals from the Authority Professionals, along with certifications that they have not and will not make reportable political contributions.

• Not to Exceed Amendment – Mr. Fischer explained the need to increase the "Not to Exceed" amount for Weiner Lesniak by \$5,000

Staff Engineer Report

Pete Canal Reported:

- MBE Mark III Electric-Primary Clarifiers 3 & 4- Contract 86 resolution to award Change order No.1 in the amount not to exceed \$11,552.
- Plant Generators-Modern Group Power Systems- to close out the contract and accept the maintenance bond.
- Treatment Plant Headwork Odor Control-draft plans and specifications are complete and seeking authorization to advertise public contract. Manuel Ponte will cover in his report.
- Glassworks, Cliffwood Avenue, Aberdeen to reduce the developers payment bond to represent the actual amount owed. The Developer has made payments lowering the balance.

WHEREAS, the Bayshore Regional Sewerage Authority (Authority) owns and operates a Power Distribution System that are in need of restoration and Mitigation; and

WHEREAS, the power distribution system is an essential component of the treatment plant, and WHEREAS, the Authority approved Resolution No. 56/16 authorizing the staff and HDR Engineering to prepare specifications and advertise a Public Contract; and

WHEREAS, in accordance with Local Public Contracts Law, the Authority advertised for the Restoration and Mitigation of the Power Distribution System, Contact 81-S and seven (7) sealed bid were received and publically opened on January 10, 2017 at 2pm EST, ranging in price from a low of \$4,793,000 to a high of \$8,344,000; and

WHEREAS, the Authority Attorney, HDR Design Engineer and Staff, have reviewed the bids and recommend award to the lowest responsive responsible bidder, PKF Mark III in the amount of \$4,793,000; and

WHEREAS, funds are available for this project.

NOW THEREFORE BE IT RESOLVED, by the Commissioners of the Bayshore Regional Sewerage Authority, that Contract 81S for Restoration and Mitigation of the Power Distribution System is awarded to PKF Mark III of Newtown, PA in accordance with the terms and conditions of contract documents at a price of \$4,793,000.

WHEREAS, the Developer has indicated they have received all local approvals including local sanitary sewer approval, and

WHEREAS, the project is expected to generate 6,841 gallons per day of wastewater, and

WHEREAS, the Bayshore Regional Sewerage Authority (Authority) Staff Engineer has reviewed the Developers application and is recommending sanitary sewer connection approval, and

WHEREAS, the Developer has paid the connection fee in full at \$187,294 and is required to pay the review fee of \$26.55, and

NOW THEREFORE BE IT RESOLVED by the Commissioners of the Bayshore Regional Sewerage Authority that Emlenrich, LLC is hereby granted sanitary sewer approval for the above referenced project, contingent upon the above requirements.

WHEREAS, due to the flooding caused by Superstorm Sandy the Bayshore Regional Sewerage Authority (Authority) suffered severe damage to the Blower Buildings creating a need to combine both buildings into a single process building to be identified as the Combined Blower Building; and

WHEREAS, the Authority contracted with Hazen and Sawyer (Hazen) of New York to design the Combined Blower Building Project 81S; and
