# MINUTES FOR REGULAR MEETING MONDAY, SEPTEMBER 18, 2017

At 7:02 P.M. on Monday, September 18, 2017 Chairwoman McMullen called the meeting of the Bayshore Regional Sewerage Authority to order and makes the following announcement:

#### **REPORTS**

Executive Directors Report, BRSA Projects, Special Reports & Connection Applications Mr. Fischer Reported:

Disaster Recovery:

Phase I

• Contract 74S – Niro Incinerator – Stone Hill reported a completion date of September 29<sup>th</sup> with minor punch list items to be done.

• Contract 80S – Combined Blower Building – aeration tanks 1-4 are complete with new diffusers. Blower Building #1 is providing air to both Plant 1 & 2. Blower Building #2 mechanical being demolished.

- Stone Hill submitted payment request #27 in the amount of \$218,359.68 and Remsco submitted payment #22 in the amount of \$15,717.24, both found acceptable by the Consulting Engineer.
- Combined cumulative phase I project payments excluding September payment totals \$24.473,704.78 Approximately \$1,100,000 will be needed to complete the two projects. Of the \$28,000,000 from the Trust short term loan allowance amount only \$26,000,000 will be needed.

#### NJEIT Phase II

- Stone Hill Construction-Contract 80S-Combined Blower Building-submitted payment application #12 is in the amount of \$121,520.00 and has been found acceptable by the Consulting Engineer.
- PKF Mark III-Contract 81S-Power Distribution System submitted payment application #2 in the amount of \$5,919.20 for zoning permit and underground exploration Blower Building (T3/T4). Metra Contracting completed the slip lining project installing a total of 3,500 feet of pipe & liner. They are completing the contract with minor repairs to manholes plus grouting between old & new pipes.

#### 2018 BRSA BUDGET

Mr. Fischer and the Staff have had two meetings regarding the 2018 Budget. The Staff submitted their budget numbers and there will be a meeting on Friday, September 22 to review each line item of the Budget. A meeting with the Finance Committee is scheduled for Monday, October 9<sup>th</sup> at 5:30 PM to review the Budget in preparation for introduction on October 16th.

#### **Staff Engineers**

#### **Pete Canal Reported:**

- Contract #96-Primary Clarifiers 1 & 2 resolution to close out the contract and accept the Maintenance Bond.
- On Sept. 7<sup>th</sup> received 2 bids for Security Services for a two year period. Award contract to the lowest bidder being Motivated Security Services in the amount not to exceed \$93,139.20.
- Authorize advertisement of bids for the Ash Basin Valve replacement & New Chamber project.
- Authorization to advertise for RFQ for Landscaping Improvement to the treatment plant.
- Holmdel Realty (Saker) of Holmdel seeking developer application approval for 8 EDU commercial space in a renovated/change of use building.
- Stone Hill Contractors Combined Blower Building-Contract 80S to award Change Order #1 in the the amount not to exceed \$230,300.55 or 3.7%.

  John Wojnas & Ed Barboe of Hazen and Sawyer presented the modifications, additions and upgrades to the Combined Blower Building 1 & 2 contract. FEMA reimbursement \$50,768.79 and non-FEMA totals \$179,531.76 Biggest part of C/O is new influent gates on all 8 tanks.
- Metra Collection System Rehab– project complete, working on punch list items. Metra & Gannett Fleming meeting Sept. 20<sup>th</sup> to discuss open claims and possible Change Orders for October meeting.

## Consulting Engineer – R3M Manuel Ponte Reported:

- Various Plant Building- all the Change Orders have to be approved by the Trust, DEP & FEMA. Change Order # is a credit in the amount of \$62,624.00.
- Headworks Odor Control September 1<sup>st</sup> system was operating with the existing scrubber and fans. The new fans are expected to be delivered in mid-October.
- Emergency Repair to the Matawan Force Main work essentially done however Pete said that

curb to curb in the whole area where the requirement is one foot past the repair area.

## Superintendents Report Mike Broyles Reported:

- Flow for August is still under 7mgd.
- The effluent quality is meeting the permit requirements.
- There were a number of odor complaints in the month of August. A number of aeration tanks were emptied and cleaned out. Also Primary Clarifier # 5 & 6 were taken down, cleaned and inspected. There was also a problem with some excavated dirt that gave off some odors which the contractor spread lime and covered it with a tarp. Most of the work in the treatment plant is Sandy related restoration and mitigation and the final contract is mobilizing in October.
- Have a difficult time getting Plant #1 to run right and had some foaming issues. Decided too many aeration tanks were on line. Took 2 tanks down and cleaned them out, effluent now looking much better.
- Incineration is operating very well.
- IFCO performed a test on the Venturi Scrubber to determine the effect of cooling water loss in the event of a power failure or other incident. IFCO reported that the temperatures without cooling are tolerable provided the fluidized blower is off line.
- IPP- DEP in Trenton had a meeting with all IPP Coordinators to locate all non-registered dental facilities guidelines will be issued.

Mr. Lauro, 9<sup>th</sup> Street, Union Beach-Odors on Dock Street complained of odors on someone else's street. Mr. Fischer said the recently installed Headworks odor project is near completion but working. He also indicated that right now activated sludge tanks are being taken down and cleaned out as part of our rehabilitation project after Sandy. He said there are three more tanks to be taken down and slight odors are expected to exist.

Charles Hoffman, Florence Avenue, Hazlet had a question about Resolution 101/17. He asked if we previously had security in the plant until the automation system was repaired. Mike Broyles said yes however due to the construction security from midnight to 7AM is deemed necessary.

#### RESOLUTIONS

<u>RESOLUTION NO. (100/17)</u>: To Secure Flood Insurance for the Authority Buildings Eligible For National Flood Insurance Program Coverage

WHEREAS, the Bayshore Regional Sewerage Authority ("Authority") owns several buildings at the Treatment Plant located at 100 Oak Street in Union Beach, NJ; and

WHEREAS, the buildings further identified as the Laboratory Office Building and Fire Water Pump Station are eligible for flood insurance under the National Flood Insurance Program (NFIP); and

WHEREAS, the Selective Insurance Company will provide total coverage of \$808,400 for Building and \$175,000 for Contents for a total premium of \$4,357.00 with a \$15,000 deductible; and

WHEREAS, as a condition of FEMA funding the Authority is required to obtain and maintain flood

insurance on all eligible buildings; and

WHEREAS, the quoted premiums and coverages have been reviewed by the Authority Risk Management Consultants, Conner Strong & Buckelew who has recommended binding these coverages; and

WHEREAS, these additional buildings require renewal, one building is being converted and allowed to flood and the remainder of the Authority buildings contain more than 50% of the building value below ground elevation and are therefore ineligible for flood insurance protection under the NFIP; and

WHEREAS funds are available for this purpose in the Authority insurance line item.

NOW THEREFORE BE IT RESOLVED, the Commissioners of the Bayshore Reginal Sewerage Authority herby authorize the payment of the above stated premiums to secure flood insurance for the named Authority Buildings for a one year term according to the building renewal date and direct the Executive Director to execute all necessary documentation to secure this coverage.

WHEREAS, the Bayshore Regional Sewerage Authority ("Authority") buildings and processes were severely damaged from Hurricane Sandy on October 29, 2012; and

WHEREAS, the Authority has a need for security services at the treatment plant during the period of construction of these buildings and processes; and

WHEREAS, the security services will monitor the plant site, buildings and alarm system during the night shift for 8 hours per day, 7 days per week; and

WHEREAS, the existing Contract with U.S. Security Associates, Inc. from Woodbridge, N.J. is expiring; and

WHEREAS, in accordance with Local Public Contract Law, the Bayshore Regional Sewerage Authority had advertised for Security Services for a two year period; and

WHEREAS, on September 7, 2017 at 1:00 P.M. two sealed bids were received and publicly opened, those bids being from U.S. Security Associates, Inc. in the amount of \$94,144.96 and Motivated Security Services in the amount of \$93,139.20 for a two year period; and

WHEREAS, the Authority Engineer, Purchasing Agent and Attorney reviewed the bids and are recommending award of the Contract to Motivated Security Services, Inc. of Somerville, NJ in the amount not to exceed \$93,139.20 for a two year period; and

WHEREAS, the funds are available for this purpose in the Authority Service Contract line item. NOW THEREFORE BE IT RESOLVED, the Commissioners of the Bayshore Regional Sewerage Authority hereby authorize award of the Contract for Security Services for a two year period to Motivated Security Services, Inc. of Somerville, NJ in the amount of \$93,139.20 in accordance with the terms and conditions of the contract documents.

WHEREAS, Holmdel Reality Development, LLC ("Developer"), is the project developer of Saker at Holmdel, located at BJ Route 35 and Centerville Rd., further designated as Block 50.31, Lot 76.01 in the Township of Holmdel, an 8 Equivalent Dwelling Units ("EDU's") Renovation Project; and

WHEREAS, the Developer has indicated they have received all local approvals including local sanitary sewer approval; and

WHEREAS, the project is expected to generate an additional 1,665 gallons per day of wastewater; and

WHEREAS, the Developer plans to add a 11,935 sf bakery under a separate application; and

WHEREAS, the Bayshore Regional Sewerage Authority ("Authority") Chief Engineer has reviewed the Developers application and is recommending sanitary sewer connection approval; and

WHEREAS, the Developer has paid the review fee of \$84.08 and connection fee of \$40,008.

WHEREAS, there is a need to amend the Contract and perform additional work necessary for the completion of the project, including: FEMA REIMBURSABLE MITIGATION @ \$50,768.79 (PCO 01 – Deletion of Process Air Header Drain @ (679.87), PCO 02 – CBB Flood Gate Sill Modifications to Landing and Loading Dock Slabs @ \$28,551.66, PCO 03 – Surge Protection for Existing Blowers @ \$19,539.00 and PCO 04 – Curb Modifications for CBB Southeast Landing Floodwall @ \$3,358.00), NON-FEMA REIMBURSABLE UPGRADES @ \$179,531.76 (PCO 70 – Actuator Stall Protection Wiring and I/O Connections @ \$10,931.00, PCO 71 – Combined Blower Building FRP Door Upgrade @ \$10,818.00, PCO

WHEREAS, Change Order No.1 will be submitted to New Jersey Environmental Infrastructure Trust for review and approval.
