# MINUTES REGULAR MEETING MONDAY, APRIL 16, 2018

At 7:00 P.M., Chairman Steiner made the following announcement:

The Regular Meeting of the Bayshore Regional Sewerage Authority will now come to order. I hereby announce that pursuant to Section 5 of the Open Public Meetings Act, that adequate notice of this meeting has been sent to the Newark Star Ledger and Asbury Park Press. Notice has also been sent to the Clerks of Aberdeen, Hazlet, Holmdel, Keansburg, Keyport, Matawan, Union Beach and Marlboro and the Western Monmouth Utilities Authority. This notice is also posted in the lobby of the Bayshore Regional Sewerage Authority Administration Building.

Chairman Steiner asked all in attendance to stand for the Pledge of Allegiance and a Moment of Silence for the safety of US Troops all over the world.

### **REPORTS**

Executive Directors Report, BRSA Projects, Special Reports & Connection Applications Mr. Fischer Reported:

#### Disaster Recovery Update

- Contract 74S-NIRO- is the only project left in Phase I and is very close to being closed out. We are currently working on getting a warrantee extension on the Mercury Scrubber.
- Contract 80S-Combined Blower Building- they are taking Blower Building #1 apart and all the piping and blowers have been removed. It will be converted to a controlled climate storage unit. All 4 blowers are installed and they are working on some communication issues. The completion date still stands at May 18<sup>th</sup>.
- PKF continues working on elevating the Power Distribution System. They are waiting on the steel for the structural support. Once the switchgear housing arrives they will raise the housing up to the

500 year flood elevation and place half of the new system on line. They will then dismantle the other half.

#### **Disaster Funding**

- Stone Hill-Combined Blower Building-Contract 80S-submitted payment #19 in the amount of \$434,648.62.
- Northeast Remsco Contract 73S final claim in the amount of \$90,987.36 with \$70K being retainage.

#### <u>Long Term Loan – Phase I</u>

• Received exhibits for Long Term Loan in the amount of \$11,561,502. NJEIT will provide \$317,802 in principal forgiveness leaving the Long Term Loan amount at \$11,243,700

#### <u>Other</u>

- The Stack Test on the NIRO Incinerator was conducted on April 4<sup>th</sup> to April 6<sup>th</sup>.
- Cornerstone and Waverly Agencies were quote solicited for a Temporary Office worker; filing, typing, answering phones general office work. Three interviews were conducted and a candidate was selected for the position. Both agencies have similar pricing structure; we chose the agency with the best response.
- Bart & Bart is working with the staff to complete the 2017 audit. A meeting next week is being held to go over Sandy financing questions. Wait on the State Pension Employers Allocation for 2019.
- Capital Budget amendment was approved by the State. No additional funds were needed

# **Staff Engineer Report Given By Robert Fischer:**

- Northeast Remsco-Contract 73S- Restoration and Mitigation of the Pump Stations close-out contract final payment in the amount of \$90, 987.36 (mostly retainage). Contract amount was \$3,379,000 plus \$206,636 in change orders bringing the Contract amount to \$3,585,636 in which 80% was Sandy related and FEMA paid for 90% of that.
- Metra Industries-Contract 90-Collection System Rehab-final Change Order #5 in the credit amount of (\$19,953.48). Additional costs in this contract was due to police traffic control and additional paving work required by the Towns. Total contract amount \$2,391,510.
- Authorization to advertise for Public Bids for Annual Ash Hauling Contract that will expire in May, 2018.
- Glassworks in Aberdeen approve the reduction of payment bond in the amount of \$1,295,872 due to payment and the reduction of our connection fee.
- Hazen and Sawyer proposal to upgrade the Dorr Oliver Incinerator prepare modification of the Title V Air Permit in the amount of \$75,310. Hazen & Sawyer will calculate emissions expected from the new Dorr Oliver, control efficiencies, risk screening along with an air modeling and analyze the dispersion according to the stack height and the distance to property line for each parameter. It will probably take 2 or 3 meeting with NJDEP so depending on the time spent the cost could be more or less.

Chairman Steiner asked about the Emergency Power Backup that was discussed at prior meetings.

Mr. Fischer said that he met with MCBOA and explained how we would tie their system into the new Generator. Arcadis did a benefit cost analysis and R3M did a conceptual design and completed Hazard Mitigation proposal. Many calls with FEMA about the project and their preliminary view is that it's a good project. Two weeks ago R3M submitted a formal proposal and we are waiting for FEMA to obligate the funds for the project.

#### **Superintendent's Report**

#### **Mike Broyles Reported:**

- The flow for March was is up, 13<sup>th</sup> largest flow in two decades.
- Effluent quality is a little higher mainly because of Combine Blower Building shut-downs
- Incinerator operation running well
- There was one odor complaint from Mr. Lauro on March 4th.
- General maintenance was done on the Sludge Belt Filter Presses prior to the Stack Test
- At the end of March an overflow was reported on First Street. We responded with pumping equipment it was Aberdeen Force Main, as it connects to the manhole upstream of our system. The work, which is being handled by Aberdeen, will last approx. 2 weeks.
- Performed the NIRO Stack Test-had issues with keeping the temperature down. It will take a few
  days to receive the results of the metal tests. During this Stack Test we bypassed the Mercury
  Scrubber to determine compliance without this unit on line.

**WHEREAS**, the Bayshore Regional Sewerage Authority ("Authority") owns and operates two-(2) fluidized bed incinerators for the destruction of residual sewage sludge solids at its treatment plant in Union Beach, NJ; and

**WHEREAS**, the Dorr Oliver incinerator ("Dorr") commenced operation in 1974 and the NIRO Incinerator ("NIRO") commenced operation in 1996 and both incinerators operated until damaged by flood during Hurricane Sandy in October of 2012; and

**WHEREAS**, the new federal Sewage Sludge Incinerator regulations at 40 CFR Part 62, also known as the SSI regs, requires all incinerators in the U.S. to meet new, more stringent emission standards as of March 21, 2017; and

**WHEREAS**, as of March 21, 2017 the restored and upgraded NIRO incinerator has been meeting these regulations and the Dorr has been shut down until upgrades can be achieved; and

**WHEREAS**, a preliminary investigation conducted by Hazen Engineers with subcontractor Chavond Barry Engineers ("CBE") indicated the Dorr Oliver incinerator can be upgraded as an existing incinerator as per the definitions at 40 CFR Part 62 consistent with the NIRO Incinerator; and

**WHEREAS**, a Title V Air Permit ("Permit") Application must be submitted to the New Jersey Department of Environmental Protection (NJDEP) to amend the Permit to allow for the upgrade and operation of the Dorr Incinerator consistent with the SSI regs; and

**WHEREAS**, Hazen Engineers has submitted a proposal to the Authority dated April 10, 2018 to submit a Permit application to the NJDEP to upgrade the Dorr incinerator; and

**WHEREAS**, the Chief Engineer and Executive Director have reviewed the proposal and find it fair and reasonable for the defined scope of work; and

**WHEREAS,** in accordance with NJAC 5:30-5.4(a)(3), the Authority certifies the availability of funds in the Unrestricted Net Position line item, to cover the maximum dollar value of the pending contract as set forth in the Resolution.

**NOW THEREFORE BE IT RESOLVED** that the Commissioners of the Bayshore Regional Sewerage Authority hereby award the contract to submit a permit application for the upgrade of the Dorr Oliver incinerator to Hazen Engineers for the Cost of \$75,300 as further detailed in their proposal dated April 10, 2018.

**WHEREAS**, the Authority staff and Consulting Engineer, Gannett Fleming have reviewed the proposal and are recommending Change Order No.5, in the amount of \$19,953.48; and

**WHEREAS,** in accordance with <u>N.J.S.A.</u> 5:30-5.4 (a) (3), the Authority certifies the availability of funds in the Capital line item, to cover the maximum dollar value of the pending contract as set forth in this Resolution.
