MINUTES REGULAR MEETING MONDAY, AUGUST 19, 2019

At 7:00 P.M., Chairman Whalen makes the following announcement:

The Regular Meeting of the Bayshore Regional Sewerage Authority will now come to order. I hereby announce that pursuant to Section 5 of the Open Public Meetings Act, that adequate notice of this meeting has been sent to the Asbury Park Press. Notice has also been sent to the Clerks of Aberdeen, Hazlet, Holmdel, Keansburg, Keyport, Matawan, Union Beach and Marlboro and the Western Monmouth Utilities Authority. This notice is also posted in the lobby of the Bayshore Regional Sewerage Authority Administration Building.

Chairman Whalen asked all in attendance to stand for the Pledge of Allegiance and a Moment of Silence for the safety of US Troops all over the world.

Reports

Pete Canal stated Highview of Hazlet (Holy Family Property) 172 apartments w/clubhouse is seeking a Developers Agreement and Connection Approval/TWA. Pete introduced Joe Hanrahan from Hammerland Engineering and Jim Smith from Highview Homes. The gentlemen explained the project which consists of 4-three story buildings and 3-two story buildings. Access to the complex will be from Highway 36 and Aumack Lane. Sewer hookup will be at the current manhole at Aumack and Hemlock Street. There will also be an inground pump station.

Executive Directors Report Robert Fischer Reported:

• Contract 81S - Power Distribution System - the Switch Gear is sitting out on the service road and

will be placed on the platform tomorrow. Substantial Completion of the project is currently November with final completion in January.

- The Authority is a member for The New Jersey Sustainable Energy Management (NJSEM), a group of 145 municipalities and authorities who bid for natural gas generation. The current contract expires in Decembe 2019 and a request for bids is going out September 11th. The bids will be accepted provided they fall below the pre-approved trigger price. Resolution to continue membership in NJSEM's group and to award contract to the lowest bidder on Sept. 11th.
- Membership with the New Jersey Utility Authority Joint Insurance Fund (NJUS JIF) expires in December 2019. The Authority has a 3 year agreement with NJUAJIF and desires continuing that relationship.

Mr. Fischer introduced Mr. Michael Bart, BRSA Auditor, to present the 2018 Audit to the Board. Mr. Bart walked the Board through each section of the audit report and explained his findings stating the financia position of the Authority is strong. The Commissioners questions were answered by Mr. Bart.

Staff Engineer Report Peter Canal Reported:

- HDR was selected as the most qualified firm to present a proposal for the Engineering Design Services on the Power Resiliency Project. After negotiation which included Mike Samuel of R3M and the Engineering Committee of the Board the proposal was accepted at \$1,028,220 approx. 6.7% on the project construction cost. Joe Frissora from HDR was present and described the scope of the design.
- Arcadis presented a proposal to provide Hazard Mitigation Plan (HMP) FEMA support in the amount of \$133,000
- The Authority and MCBOA completed a Memorandum of Understanding for the design and construction of the Power Resiliency Project as power will be supplied from the Project to the MCBOA Pump Station in Union Beach in the event of a Power Failure or major outage.
- Annual Security Services Contract No. 113 opened 2 bids (1) Wisdom Protective Services \$53,564.72 and (2) Universal Protection Services \$58,965.68. Award Contract to the lowest bidder-Wisdom Protective Services for a one-year period.

Consulting Engineer – R3M Manuel Ponte Reported:

- Repurposing Blower Bldg.#1 to Storage Bldg.- Shorelands submitted shop drawings for review. Mobilizing soon to begin demolition.
- Working with Pure Technology to obtain GIS mapping information.
- Preparing a proposed scope of services for Phase II Condition Assessment & Planning Program for the force mains.

3rd Quarter 2018/2019 Flow Report

- Flows are down from last quarter but the percentage is in line with the previous year.
- Hazlet and Union Beach flow percentages are lower recently with the heavy rain because they are calculated by EDU's instead of their actual flow in accordance with the Sewer Service Agreements.

Superintendent's Report Mike Broyles Reported:

• The flow is down some 800,000 gpd for July due to dryer weather

- Effluent flow is exceptional, 99% & 98% removal of TSS and BOD respectively.
- Fuel Oil slightly higher due to the warmer weather causing sludge degradation prior to incineration.
- Odor complaints in July- one from 601 5th St. and several from 705 9th Street- Odor Control Tower #4 was out of service due to power failure for approx. ½ hour.

Mr. Fischer congratulated Mike on the 99% and 98% removal.
