### Dorr Oliver Rehabilitation & Power Resiliency Projects Presentation

### Jamie Zimmerman of HDR provided a presentation on the Power Resiliency & Dorr Oliver Projects

- 1. The Power Resiliency Project is intended to provide BRSA & MCBOA with reliable power in anticipation of, and during major storm events.
  - Generation Building will house three (3) 1500KW generators that will power both facilities
  - Generation Building will be constructed atop the existing wind turbine pad and will be elevated above the 500-year flood level
  - It is estimated that the generators will require 2 hours/month maintenance
  - Exhaust vents of the Generation Building will face the Bay. Modeling predicts the noise level to be below the 50-decibel limit at the residential property lines.
  - Project also includes flood proofing the existing pump station walls at the MCBOA facility to the 500-year flood level
  - Construction access via 9<sup>th</sup> Avenue for BRSA and Edmunds Avenue for MCBOA
  - Expect delivery of equipment and concrete work to take place early-mid 2024. Pile work expected to start late 2023 and continue into 2024
  - Projected project schedule:
    - o Project Advertised beginning March 16, 2023
    - o Bid Opening on May 18, 2023
    - o Award Contract in August 2023
    - o Begin Construction in Fall 2023. Expect construction to continue for twenty-six (26) months
  - Latest construction cost estimate is approximately \$25 Million
- 2. The Dorr Oliver Incinerator Rehabilitation Project is intended to provide BRSA with a fully redundant back-up incinerator that meets the current emissions regulations.

- Project includes rehab of the Dorr Oliver Incinerator and installation of a new pipe tuyere system, new heat exchanger, new stack and emissions controls, roof hatch for maintenance and removal, as well as Plant Control Building improvements and new electrical equipment for the incinerator
- To meet emissions regulations, a new quench and wet scrubber will be installed inside the building and a new mercury scrubber will be installed outside as well as a new 87 foot tall stack
- Title V permit was obtained for the project in 2019. A NJDEP Land Use permit is not required. We are working on step 4, Engineering Design and Specifications, of the IBANK application.
- Current construction schedule:
  - Award Contract by December 2023
  - Begin Construction in January 2024. Expect construction to continue for twenty-four (24) months
- Latest cost estimate is approximately \$20 Million

A brief discussion took place concerning the equipment noise levels and Power Resiliency Generator building height.

## Reports BRSA Projects, Special Reports & Connection Applications

#### 1. Executive Director's Report

- Administration We recently executed the contract agreement with Verily for the WastewaterSCAN program. BRSA staff met today to develop a plan to move forward and it is anticipated that we will begin sampling within the next couple of weeks. The Signaturely digital signature program is now up and running. One Commissioner has set up their profile and the IT Department will be reaching out to the rest of the Commissioners to set up their digital signatures.
- **Disaster Recovery Update** HDR provided an update on the Power Resiliency Project in their presentation. The project went out for bid advertisement on March 16, 2023 with a pre-bid meeting scheduled for April 13, 2023. There are already 13 planholders of the Contract Documents. Bid opening will take place on May 18, 2023 barring any addendums and we hope to award in June or July.
- **Dorr Oliver** HDR is currently working on the sixty (60) percent design milestone, and we will have them back for another presentation once the ninety (90) percent or final design is complete.
- Finance The Electrical Supply Aggregation Group is opening bids on Wednesday, March 22, 2023. If favorable, we will look to award next month. There are payments to approve for Project Fund (PF) No.3, for Power Resiliency Generation Project (PRG) for Cleary Giacobbe Alfieri Jacobs in the amount of \$814, HDR in the amount of \$815 and R3M Engineering, Inc. in the amount of \$1,189.50.
- Other On March 1, 2023, a leak was discovered from our Raritan Valley Force Main in the wooded easement near the Raritan Valley pump station. Our emergency contractor, CRS (Cruz) was immediately mobilized, and the repair and bypassing was completed on March 2, 2023. Mr. Canal thanked the BRSA staff involved in the repair for working around the clock to complete the repair so quickly. He then congratulated Roy Anderson,

who was presented with an Individual Wave Award at the Spring AEA Utility Management Conference for his years of public service.

Commissioner Whalen stated that he saw Chuck Theodora and another BRSA employee on Green Acre Drive in Hazlet on Friday checking for the cause of high flow through one of our meter chambers and asked if the cause had been determined. Mr. Anderson explained that the issue was due to a partial blockage in the line, causing the line to surcharge back to the meter chamber. A Jet-Vac truck was called in Friday afternoon and the blockage was cleared.

#### 2. Principal Engineer's Report

- Contract 122 Interceptor Sewer Rehabilitation Phase 3 The work has been completed. The maintenance bond and close-out documents have been submitted. There is a Resolution on tonight to close out the Contract.
- Contract 124 West Keansburg Pumping Station Bypass Facility & Improvements The contractor repaired a small leak upstream of the new mag meter on February 22, 2023 and the project is now complete. The maintenance bond and close-out documents have been submitted and approved. There is a Resolution on tonight to close out the Contract.
- Contract 139 Niro Incinerator Primary Heat Exchanger Rehabilitation We received one (1) bid on February 14, 2023 from Iron Hills Construction in the amount of \$563,211.00. The bid came in higher than the estimated cost provided by Chavond-Barry Engineering Corp. After some additional discussions with Chavond-Barry and the manufacturer, Chavond-Barry updated their cost estimate. As a result, we feel comfortable awarding the project. There is a Resolution tonight to award Contract 139 Niro Incinerator Primary Heat Exchanger Rehabilitation to Iron Hills Construction, Inc. of Easton, PA in the amount of \$563,211.00.
- Contract 140 Raritan Valley Force Main Replacement The project is close to the end of the design phase. The staff met with PS&S on March 8, 2023 to go over the final submittal. PS&S is now addressing a few small comments. We received word from the NJTA that our application for our License to Cross Agreement is complete and it will be issued once the final drawings are received by the NJTA. We submitted our Land Use permit in February and are awaiting NJDEP review, which generally takes 60-90 days. We have a Resolution tonight to authorize advertisement of the Contract for Public Bids once we are ready to proceed.
- Contract 144 Matawan & West Keansburg Pump Station ATS & Electrical Upgrades The project bid opening took place on March 1, 2023. The lowest bid from Travis, Inc. of East Hanover, NJ in the amount of \$609,428.00 was rejected at the advice of our attorney due to a failure to provide a Public Works Contractor Registration Certificate for one of their Sub Contractors. As a result, we are moving forward with the second lowest bid from LaManna Electric, Inc. of Trenton, NJ in the amount of \$625,350.00. For reference, the Engineer's estimate came in at \$707,000.00, higher than the bid being recommended for award. There is a Resolution on tonight to award the Contract to LaManna Electric Inc. of Trenton NJ. We also solicited a proposal from Mott MacDonald for Construction Engineering Services. Due to the complexity of the project, we asked them for full time observation services. The estimated time frame requiring bypass will be about one (1) month with some additional prep work and cleanup. We

- reviewed the proposal and find it to be fair and reasonable. We have a resolution on tonight to award the Construction Phase Engineering Services proposal for the project to Mott MacDonald, LLC of Iselin, NJ in the amount of \$81,500.00.
- Contract 145 Interceptor Sewer Rehabilitation Phase 4 This project involves the rehabilitation of four areas in Union Beach, including the area of Shore Road where the previously discussed stoppage took place on Friday, March 17. The rehabilitation of these four areas includes cleaning, bypassing, and lining. The project went out to bid on February 24, 2023 and a pre-bid meeting was held on March 9, 2023. Bid opening is scheduled for April 6, 2023. We will possibly award this project at the April Public Meeting.
- Plant Headworks Rehabilitation & Upgrades This project includes the replacement of the two (2) mechanical bar screens, replacement of influent sluice gates, evaluates the addition of a main bypass chamber, and rehabilitation of concrete and application of a protective corrosion barrier in the wet well. We expect to solicit proposals for the engineering design & bidding services from our Pre-Qualified Capital Improvements list in the Treatment Plant Category in March or April.
- RFQ 2023-03 Preventative Maintenance, Calibration & Repair of Instrumentation Equipment for a One (1)-Year Period We received one (1) quote from Miller Energy, Inc. of South Plainfield, NJ in the amount of \$24,077.50. Miller Energy, Inc works hand in hand with ABB, whom was awarded this work the last few years. There is a Resolution on tonight to award RFQ 2023-03 Preventative Maintenance, Calibration & Repair of Instrumentation Equipment for a One (1)-Year Period to Miller Energy, Inc. in the amount of \$24,077.50.
- Regent Park, B.143, L.1.02 & 12, Lloyd Road & Thornton Road, Marlboro This project, Regent Park, was originally approved in May, 2020. The developer's agreement was not executed until 2021. It was sold to KRE Lloyd Road after they had paid the first part of the developer's agreement. The Developer has made the final payment in the amount of \$928,168.00, representing the adjusted balance of connection fees for Phases 2,3,4 & 5 of the project. There is a Resolution tonight to authorize release of the sewer connection payment bond and lien for the Regent Park project, Block 143, Lots 1.02 & 12 in Marlboro, NJ.

#### 3. Consulting Engineer – R3M Report

- Power Resiliency System We are making good progress on this project
- **WPCP-Site Specific Odor Control Design** The project went out to bid on March 8, 2023 and a pre-bid meeting is scheduled for March 22, 2023. Bid opening is scheduled for April 26, 2023.
- Administration Building Roof Replacement The contractor submitted a substitution to the specified roofing system and the manufacturer cannot warranty the system against uplift up to the specified wind force. The contractor is now seeking alternatives.
- West Keansburg Pump Station Bypass and Meter Facility Construction Services The work is completed and final as-built drawings are being completed this month.
- Engineering Design Services for West Keansburg Force Main Replacement The contractor has not yet provided the additional shop drawings requested since the last update. The Contract is currently on hold due to the NJDEP requirements that no work take place in that location between April 1 through August 31.

• Condition Assessment and Planning Program of Authority Force Mains: Phase III – The hydraulic evaluation presentation was provided to the BRSA staff and the report will be provided this month.

A brief discussion ensued regarding the plant odors and the delays in the progress of the Site-Specific Odor Control Design project.

#### 4. Director of Operation's Report

- Plant Performance The total plant flow for the month of February was 209 MG, which is a 44 MG decrease in the monthly total when compared to January. Half of this decrease can be attributed to February being a short month. Average daily flow in February was approximately 700,000 gallons per day less than January's average. Total flow for the month of February for the IFF Union Beach facility was 1,198,000 gallons and the IFF Compounding Facility in Hazlet was 342,250 gallons.
- Effluent Quality The effluent quality continued to degrade slightly into the beginning of February, resulting in slightly higher numbers. The influent numbers were also slightly higher, which resulted in percent removal for CBOD and Suspended Solids remaining at 96%. Even with the increase in effluent numbers, we are still only at 40-45% of our permit limits. We made adjustments to the balance of flow between the two plants and we have seen some improvement to the effluent quality through the end of February into the month of March.
- Compliance, Safety, and Training Management Staff met to discuss the implementation of the Operator License Exam Training Program, which is being provided by PS&S to provide review of the materials covered on the Operator Licensing Exam. There are currently 8-9 participants in the program, which meets twice per week for 1-1/2 hours. The program seems to be going well through the first three weeks. Professional Health Services performed hearing, pulmonary function, and respirator FIT tests on the employees to fulfill the requirements of the Hearing Protection and Respiratory Protection Programs. The Authority received the NJUA JIF Safety Incentive Award for the 19<sup>th</sup> consecutive year. Additionally, the Authority also received a certificate for "1 Year Lost Time Accident Free" for 2022.
- Industrial Pretreatment Program All permittees reported for the first time under their new permits. IFF Research & Development missed sampling for Nitrogen, Ammonia for the month of January. This is a new requirement in the renewed permit. The IFF R&D facility's compliance history is very good. However, the Authority Rules and Regulations and the NJ Administrative Code require a mandatory minimum penalty for this type of violation. As a result, a Notice of Violation and Penalty Assessment will be issued.
- Computers, Instrumentation, and Network Administration We are continuing the installation of the transformer monitoring equipment which allows us to monitor transformer temperatures and incoming/outgoing voltages from our SCADA system. Staff installed Voice Over Internet Protocol (VOIP) phones in several buildings where the copper phone lines were damaged. Every building throughout the plant now has an operating phone.
- Treatment Plant Maintenance The maintenance staff repaired two scum pumps, which feed grease to the belt filter presses, and installed a spare polymer gear pump for Belt Filter Press #4. A new dehumidifier was installed in Return Sludge Pump Station #1.

- A reducer flange was replaced on Scrubber Ash Slurry Pump #2. Staff also replaced 2 rams for the Schwing Sludge Cake Feed Pump.
- Collection's System Maintenance The staff continued to clean the West Keansburg Pump Station now that the contractor has completed their work. Truck #8 broke down and was brought to Toms Ford for repair. The truck was returned once repairs were completed. Repairs were made to the BIOXIDE feed system and the BioAir chemical feed pump at the West Keansburg Pump Station.

Mr. Anderson noted that, in addition to the staff members that are taking part in the Operator License Exam Training Program, we have 2 additional maintenance personnel that are taking the Advanced Collection's course through Rutgers University.

**WHEREAS**, the Bayshore Regional Sewerage Authority ("Authority") owns and operates a fluidized bed incineration system for thermal destruction of organic solids generated and removed from the treatment process; and

**WHEREAS**, the primary heat exchanger is an integral and necessary component of the fluidized bed system and the existing heat exchanger was recently replaced the spare unit; and

WHEREAS, the Authority has a need to rehabilitate the primary heat exchanger; and

WHEREAS, the Authority has contracted with Chavond-Barry Engineering Corp., to develop Contract 139, NIRO Incinerator Primary Heat Exchanger Rehabilitation with technical specifications for the work and design documents for the solicitation of public bids, by Resolution No. 68/22; and

**WHEREAS**, in accordance with Local Public Contracts Law, the Authority advertised for Contract 139, NIRO Incinerator Primary Heat Exchanger Rehabilitation, and one (1) sealed bid was received and publicly opened on February 14, 2023 at 11:00 A.M., with the low bidder being Iron Hills Construction, Inc. of Easton, PA in the amount of \$563,211.00; and

**WHEREAS,** the Authority Attorney, Principal Engineer and Chavond-Barry Engineering Corp. have reviewed the bids and are recommending award of the Contract to Iron Hills Construction, Inc. of Easton, PA in the amount of \$563,211.00; and

**WHEREAS**, in accordance with N.J.S.A 5:30-5.4 (a) (3), the Authority certifies the availability of funds in the Incinerator Equipment & Improvements line item of the Authority Capital Budget, to cover the maximum dollar value of the pending Contract as set forth in the Resolution.

**NOW THEREFORE BE IT RESOLVED,** the Commissioners of the Bayshore Regional Sewerage Authority that Iron Hills Construction, Inc. of Easton, PA is hereby awarded Contract 139, NIRO Incinerator Primary Heat Exchanger Rehabilitation in the amount of \$563,211.00 in accordance with the terms and conditions of the bid and Contract Documents.
