The Bayshore Regional Sewerage Authority (BRSA) owns and operates a Wastewater Treatment Plant in accordance with the NJPDES Permit Nos. NJ0024708 and NJG0198145 as issued by the NJDEP Division of Water Resources and NJDEP Bureau of Pretreatment and Residuals respectfully. The intent of this solicitation is to obtain a State of New Jersey certified laboratory to secure samples, perform analysis, and provide written reports for specialized testing required under the NJPDES Permit for all requirements beyond the capability of the BRSA laboratory. The specialized laboratory testing work includes securing samples, performing analysis, and providing written reports. The laboratory is required to provide sample containers for collection of samples, pick up the samples from the BRSA Wastewater Treatment Plant site and transport the collected samples to the laboratory. The required testing and frequency of analysis are listed in the attached sheets. Your firm will be required to comply with the Affirmative Action Requirements of P.L. 1975, c. 127 (N.J.A.C. 17:27). Quotations must be accompanied by a copy of the NJDEP Laboratory Certification along with a current Annual Certified Parameter List (ACPL). If your laboratory is not certified for a particular parameter, you must employ a laboratory that is. The parameter, name and address of the laboratory, copy of their NJDEP Laboratory Certification, and their current ACPL must be included on the Quotation Pages.
