WHEREAS, for better control of costs and to realize reimbursement of these services by FEMA, the Authority has asked Arcadis to provide a detailed Cost Breakdown for each task of their original proposal and provide a not to exceed overall fee; and

WHEREAS Arcadis presented their revised proposal to the Board of Commissioners at a Public Meeting on June 10, 2013; and

WHEREAS, these services are a necessary component of determining the proper cost effective mitigation proposal to present to FEMA for protection of Authority assets against future flooding events.

WHEREAS, the Authority's Staff Engineer and Purchasing Agent have reviewed the quotations and recommend award to Aqua Pro-Tech Laboratories, Inc. (APL).

WHEREAS, the quotes were publicly opened and read aloud and the lowest responsible and responsive quote was provided by Foley, Inc. of Piscataway, NJ having submitted a total quote price of \$ 22,728.92 for a two-year period, and

WHEREAS, the funds are available and budgeted for this purpose

WHEREAS, the Authority's Staff Engineer and Purchasing Agent have reviewed the quotations and recommend award Foley, Inc.

NOW THEREFORE BE IT RESOLVED that Foley, Inc. is hereby awarded a contract for furnishing Annual Generator Service, in accordance with the terms and conditions of the quotation documents for a total cost of \$ 22,728.92.

WHEREAS, the bids were publicly opened and read aloud and the lowest responsible and responsive bid was provided by Spectraserv, Inc. of Kearny, NJ having submitted a total bid price of \$34,800.00 for a two-year period, and

WHEREAS, the funds are available and budgeted for this purpose

WHEREAS, the Authority's Staff Engineer, Purchasing Agent and Attorney have reviewed the bids and recommend award of the contract to Spectrasery, Inc.

NOW THEREFORE BE IT RESOLVED that Spectraserv, Inc. is hereby awarded a contract for furnishing Annual Disposal of Grit and Screening, in accordance with the terms and conditions of the bid document for a total cost of \$34,800.00.

BE IT FURTHER RESOLVED that the bid bond of the second low bidder, Freehold Cartage, Inc., shall be retained until a contract is executed with the low bidder.

RESOLUTION (105/13): to award the Hauling & Disposal for Dewatered Sludge Cake to Russell Reid

WHEREAS, the Bayshore Regional Sewerage Authority has a need to Haul and Dispose of Dewatered Sludge Cake from its facility at 100 Oak Street, Union Beach, NJ to the disposal site located at the Stony Brook Regional Sewerage Authority at 290 River Road in Princeton, NJ; and

WHEREAS, the Authority Commissioners authorized the advertisement of Public Bids for the Hauling and Disposal of Sludge Cake on April 15, 2013 by Resolution 74/13; and

WHEREAS, on June 5, 2013 at 2:00 P.M. two sealed bids were received with the lowest responsible bid being from Russell Reid with a bid price of \$241,600.00; and

WHEREAS, the funds are available for this purpose; and

WHEREAS, the Authority's Staff Engineer, Consulting Engineer, Purchasing Agent and Attorney have reviewed the bids and recommend award of the contract to Russell Reid; and

WHEREAS, both bids contained minor, non-material deficiencies which are being waived by the Authority.

NOW THEREFORE BE IT RESOLVED that the Commissioners of the Bayshore Regional Sewerage Authority award the contract 66-S for Hauling and Disposal of Dewatered Sludge Cake to Russell Reid of Keasbey, NJ, in accordance with the terms and conditions of the bid documents and defects as noted in the Authority's Attorney letter dated June 13, 2013 are non-material and are being waived.

WHEREAS, the Bayshore Regional Sewerage Authority has a need to hire a Licensed Site Remediation Professional (LSRP) to complete remedial investigation activities at the facility site located at 100 Oak Street, Union Beach, NJ; and

WHEREAS, the RI activities will be based upon the findings of the preliminary assessment report recently completed for the site and is anticipated to include a non-invasive geophysical survey, groundwater investigation and an NJDEP and USEPA file review; and

WHEREAS, the Authority desires to seek proposals from qualified Engineering Firms for the performance at a Remedial Investigation by a Licensed Site Remediation Professional.

NOW THEREFORE BE IT RESOLVED the Commissioners at the Bayshore Regional Sewerage Authority authorize the qualified Purchasing Agent to advertise a Request For Proposal (RFQ) for Remedial Investigation Activities at the Authority facility site.

RESOLUTION (107/13): to award Engineering Amendment for Wind-to-Energy Contract #54 to PS&S

WHEREAS, the Bayshore Regional Sewerage Authority (BRSA) entered into an Agreement with Paulus, Sokolowski and Sartor, LLC (PS&S) to provide engineering services for the Windto-Energy Project, Contract 54, by Resolution (100/09) dated November 16, 2009; and

WHEREAS, the BRSA wind turbine components and ancillary equipment were damaged by flooding from Super Storm Sandy, and

WHEREAS, there exists a need to evaluate the damaged foundation and equipment and assess the impact of the FEMA Advisory Base Flood Elevations on the Wind-To-Energy project, and

WHEREAS, PS&S has the resources necessary to perform the damage assessment report and project engineering, and

WHEREAS, PS&S has submitted an amendment to their proposal, dated June 7, 2013, in the amount of \$34,500 for a damage assessment and impact evaluation, and additional engineering management going forward, and

WHEREAS, funds are available for this work, and

WHEREAS, the proposal has been reviewed by BRSA Staff and found to be fair and reasonable.

NOW THEREFORE BE IT RESOLVED the Commissioners award Engineering Amendment for Wind-To-Energy Contract No. 54, to PS&S at a cost of \$34,500.

WHEREAS, the Authority's Consulting Engineer, R3M, has evaluated the HVAC units in the Laboratory/Office Building and provided a recommendation to replace them due to age condition.

WHEREAS, the estimated costs of this work will exceed the public bidding threshold; and WHEREAS, the Authority requires authorization to solicit bids for a Public Contract; and WHEREAS, the Authority has funding available for this project.

NOW THEREFORE BE IT RESOLVED by the Commissioners of the Bayshore Regional Sewerage Authority that the Staff Engineer and the Consulting Engineer (R3M) are hereby authorized to advertise through Public Contract in the Authority's official newspaper and web site for Contract NO. 13-70, the HVAC repair and replacement in the Laboratory/Office Building.

Commissioner Sutton informed Charles Hoffman that the Engineer checked the base of the turbine. Mr. Hoffman said Mr. Lavin asked about BRSA addressing NJEIT about the turbine project. He asked if BRSA received any answers, he said he has a right to know what they said. Jim Gorman stated that it's a complex litigation and a matter of confidentiality.

Charles Hoffman asked if he could go to the state with an OPRA request. Jim Gorman said OPRA is for records not conversations.
