Bill Shewin of Hazlet Township asked why the preliminary budget was \$7,000,000 when the projected expenditure for 2013 shows \$6,000,000.

The Executive Director responded that there will be a large difference in expenditures for fuel oil in 2014 of \$580,000 alone due to the Dorr Oliver Incinerator. Removal of Ash will create an additional \$150,000. There are contingencies made for anticipated equipment failure due to corrosion from Hurricane Sandy also figured into the budget.

RESOLUTION No. (144/13): 2014 Authority Budget Resolution BAYSHORE REGIONAL SEWERAGE AUTHORITY FISCAL YEAR: 2014 FROM: JAN. 1, 2014 TO: DEC. 31, 2014

WHEREAS, the Annual Budget and Capital Budget for the Bayshore Regional Sewerage Authority for the fiscal year beginning, January 1, 2014 and ending, December 31, 2014 has been presented before the governing body of the Bayshore Regional Sewerage Authority at its open public meeting of October 21, 2013; and

WHEREAS, the Annual Budget as introduced reflects Total Revenues of \$ 9,591,630, Total Appropriations, including any Accumulated Deficit if any, of \$7,016,630 and Total Unrestricted Net Assets utilized of \$0.00; and

WHEREAS, the Capital Budget as introduced reflects Total Capital Appropriations of \$2,575,000 and Total Unrestricted Net Assets planned to be utilized as funding thereof, of \$2,575,000; and

WHEREAS, the schedule of rates, fees and other charges in effect will produce sufficient revenues, together with all other anticipated revenues to satisfy all obligations to the holders of bonds of the Authority, to meet operating expenses, capital outlays, debt service requirements, and to provide for such reserves, all as may be required by law, regulation or terms of contracts and agreements; and

WHEREAS, the Capital Budget/Program, pursuant to N.J.A.C. 5:31-2, does not confer any authorization to raise or expend funds; rather it is a document to be used as part of the said Authority's planning and management objectives. Specific authorization to expend funds for the purposes described in this section of the budget, must be granted elsewhere; by bond resolution, by a project financing agreement, by resolution appropriating funds from the Renewal and Replacement Reserve or other means provided by law.

NOW, THEREFORE BE IT RESOLVED, by the governing body of the Bayshore Regional Sewerage Authority, at an open public meeting held on October 21, 2013 that the Annual Budget, including appended Supplemental Schedules, and the Capital Budget/Program of the Bayshore Regional Sewerage Authority for the fiscal year beginning, January 1, 2014 and ending, December 31, 2014 is hereby approved; and

BE IT FURTHER RESOLVED, that the anticipated revenues as reflected in the Annual Budget are of sufficient amount to meet all proposed expenditures/expenses and all covenants, terms and provisions as stipulated in the said Authority's outstanding debt obligations, capital lease arrangements, service contracts, and other pledged agreements; and

**BE IT FURTHER RESOLVED**, that the governing body of the Bayshore Regional Sewerage Authority will consider the Annual Budget and Capital Budget/Program for adoption on December 16, 2013.

#### RESOLUTION NO. (145/13): To award the Security Service bid to Colonial Security

WHEREAS, the Bayshore Regional Sewerage Authority has a need for security services at the treatment plant, and

WHEREAS, the security services will monitor the plant site, buildings and alarm system for 8 hours per day, 7 days per week, and

WHEREAS, quotes were received on October 8, 2013 for security firms with the lowest quote being Colonial Security of Kenilworth, NJ at a cost of \$14.10 per hour, and

WHEREAS, these services will be limited to an 8 month period commencing on October 28, 2013, and

WHEREAS, this contract is being awarded based on a fair and open process, and WHEREAS, funds are available of this purpose.

NOW THEREFORE BE IT RESOLVED the Commissioners of the Bayshore Regional Sewerage Authority approve the hiring of Colonial Security as security services for the Authority for an 8 month period contingent upon Colonial Security providing the necessary insurance, indemnification and hold harmless agreement, and proof of security officer certification with the Security Offices Registration Act. WHEREAS, the proposals were evaluated in accordance with the stated evaluation technique and criteria which assigns a weight to each of five (5) categories, and

WHEREAS, after evaluation of the proposals the highest ranking proposal was submitted by O'Brien & Gere at a cost of \$10,000, and

WHEREAS, funds are available for this purpose, and

WHEREAS, this contract will be awarded in accordance with a fair and open process.

NOW THEREFORE BE IT RESOLVED the Commissioners of the Bayshore Regional Sewerage Authority award the contract for Environmental Consulting Services, for a licensed site Remediation Professional to assist the Authority with Environmental Engineer Services in the close-out of one active case and to meet compliance deadline schedules with a second case.

WHEREAS, said flow figures have been calculated from actual meter readings, maintenance service reports, meter calibration reports and other data, and

WHEREAS, said flow figures have been reviewed by the Commissioners of this Authority, and WHEREAS, in accordance with the Service Agreement Union Beach and Hazlet have certified the number of respective EDU's connected to the system in the prior year.

NOW THEREFORE BE IT RESOLVED that this Authority hereby accepts the flow calculations, certified by R3M for the Fourth and Final Quarter of the year 2012/2013.
